The Cuba-Rushford Central School District is requesting sealed bids for FILTERS for the 2021-2022 fiscal year.

Please include delivery time. Filters will be inspected on receipt and any not meeting bid specs will be refused and returned at vendors cost.

These specifications are minimum. Please note any exceptions or clarifications. This bid is for one change of filters.

Specifications should be as follows:

- 100% polyester synthetic fiber woven to produce a three stage panel. Each stage will catch larger to smaller particles. The last ply is to catch any bypass or fiber break off.
- Filtration shall meet MERV 8 standards at 1495 CMF.
- Each filter shall be manufactured to fit the air handler or univent exactly with no use of spacers.
- Filtration media must surround a wire to wire construction. Wire shall be 9-gauge.
